



DATA PROTECTION NOTICE

EU Day against Impunity 2024 – online event

As Eurojust collects and further processes personal data, it is subject to *Regulation (EU) 2018/1725 of 23 October 2018 on the protection of natural persons with regard to the processing of personal data by the Union institutions, bodies, offices and agencies and on the free movement of such data, and repealing Regulation (EC) No 45/2001 and Decision No 1247/2002/EC* ('the Regulation').

The following information is provided as per Articles 15 of the Regulation.

1. Context of the processing activity and Controller

On 23 May, the Genocide Network Secretariat, Eurojust, the European Commission and the Belgian Presidency of the EU are co-hosting the 9th EU Day against impunity ('the EUDAI event'). The EUDAI 2024 event will take place on the Webex platform. Please find here the [data protection notice](#) for the Webex platform. The event will be streamed by a contractor of Eurojust, Instant News Services (INS), via YouTube to the Streamcage platform, and publicly shown live on the date of the event. Users are advised to check the data protection notices of [Streamcage](#) and [Youtube](#) before using those platforms. Further, it will be recorded and published on the Eurojust YouTube channel in an edited format.

Processing of personal data for the purpose of the organisation of the event is under the responsibility of the controller, the Head of the Genocide Network Secretariat, who can be reached at the address GenocideNetworkSecretariat@eurojust.europa.eu.

The Corporate Communications Unit (CCU) of Eurojust is supporting the event with technical measures to make it accessible to the relevant stakeholders (recording and livestreaming). Collection and processing of personal data for the streaming and recording of the event within CCU are therefore under the responsibility of a different controller, who is the Head of the CCU, and can be reached at the address DP_comms@eurojust.europa.eu.

2. What personal information do we collect, for what purpose, under which legal bases and through which technical means?

Purpose of the processing

The purpose of the processing is to enable participation in the EU Day against Impunity and its distribution to the widest possible audience, including via supplying an interpretation into French.

Types of personal data

The following **categories of personal data** are processed in the context of the above mentioned processing activity:

For speakers joining in Webex:

Name, Surname, job title, image (as shared in Webex) and voice (as shared in Webex). Speakers are requested to consent to processing of their personal data in a dedicated form.

For interpreters:

Voice (as provided during the event in the course of interpretation). Interpreters are informed of the processing of their personal data.



For participants joining in Webex:

- **Registration to the event through the Eventsforce platform**

Invitees will be requested to register through the Eventsforce platform administered by the Eurojust Events and Logistics Unit. Please consult the [data protection notice for Eventsforce](#). During the registration, participants will be requested to share:

- i. First Name
- ii. Last Name
- iii. Function and organisation
- iv. Email address

This personal data will be used by the Genocide Network Secretariat in order to share the Webex videolink and practical/technical information with registered participants ahead of the event, and to ensure that participants joining the Webex videocall have correctly registered. The data collected will be deleted after the event, at the latest within 5 working days after the end of the event.

- **Registered participants joining the Webex videocall**

At the beginning of the Webex video call, the participants are requested to consider that the Webex feed will be streamed live to a web platform and protect their personal data by not sharing video or audio (e.g. by keeping cameras and microphones off). For viewers via livestream:

A link will be distributed to a specific webpage on the **Streamcage** platform, made available for this purpose by the company Instant News Services (INS), under framework contract 2021/EJ/12/PO/INS and their subcontractor Cagency (please see the [Streamcage platform](#) data protection notice). The Streamcage platform uses Youtube as a video player that is embedded on the page.

To view the event on this page, users will need to consent to the use of cookies based on privacy information displayed on the page. The platform will collect the following data:

1. IP address
2. Connection time
3. Browser type

This information is necessary for the correct functioning of the platform as well as to have statistics on how many viewers watch the event live. After the event, the data collected will only be used anonymised and as an aggregate for statistical purposes, and will be deleted once it is processed for this purpose, at the latest 24 hours after the end of the event.

Further, the event will be recorded and published on the Eurojust YouTube channel in an edited format, and can be viewed from there as an alternative to the Streamcage platform.

Legal basis

The processing of personal data is necessary to organise the EU Day against impunity event online, aiming to raise awareness of Eurojust partners and the broader public on efforts to fight against impunity for core international crimes. The processing will be based on Article 5 (1) (a) of the Regulation, more specifically Article 2(1) of Regulation (EU) 2018/1727 ('the Eurojust Regulation').



The processing of pictures and videos by CCU is subject to Article 5(1)(d) of the Regulation. The pictures and video shoots will be only processed on the basis of your consent. Please note that you have the right to withdraw your consent at any time. To do that, please contact the Corporate Communications Unit via the following e-mail address: DP_comms@eurojust.europa.eu, and we will do what is technically and organisationally possible to accomplish your request as soon as possible.

Technical means

The EUDAI 2024 event will take place on the Webex platform. Please find here the [data protection notice](#) for the Webex platform.

The event will be streamed by a contractor of Eurojust, Instant News Services, via YouTube to the Streamcage platform (please see the [Streamcage platform](#) data protection notice), and publicly shown live on the date of the event. Further, it will be recorded and published on the Eurojust YouTube channel in an edited format.

3. Who has access to your personal data and to whom is it disclosed?

The list of registered participants on Eventsforce will be transmitted by the Events and Logistics Unit to the Genocide Network Secretariat. Access to the personal data will not be shared with any other persons, either within or outside of Eurojust.

The livestream and the video recording of the event as well as still images selected from the event are available to the general public on the Streamcage platform and YouTube. The recording may further processed as described in the [Date protection notice on the taking and processing of pictures and videos by Eurojust](#). This includes storage internally by the Corporate Communications Unit in a secure file storage, with access granted to duly authorised members of this unit.

4. How do we protect and safeguard your information?

All IT tools at Eurojust are developed according to a standard set of security standards and are thoroughly tested accordingly, to ensure robustness and reliability.

5. How can you verify, modify or delete your information?

You have the right to access your personal data and to relevant information concerning how we use your personal data. You have the right to request rectification of your personal data. You have the right to ask that we delete your personal data or restrict its use. Where applicable, you have the right to object to our processing of your personal data, on grounds relating to your particular situation. Where applicable, you have the right to your data portability. We will consider your request, take a decision, and communicate it to you. For more information, please see Articles 14 to 21, 23 and 24 of Regulation (EU) 2018/1725. Please note that in some cases restrictions under Article 25 of Regulation (EU) 2018/1725 may apply (see College Decision 2020-04 of 15 July 2020 on internal rules concerning restrictions of certain data subjects' rights in relation to the processing of personal data in the framework of activities carried out by Eurojust, available in the Eurojust website [here](#)).
